To enter into a Swaption with CBH Grain, You are required to be a 'wholesale client' under the Corporations Act. An assessment will be performed by CBH Grain to determine whether You are a wholesale client. CBH Grain will consider You to be a wholesale client if the value of the Notional Amount of the Swaption equals or exceeds \$500,000. Further assessment will determine the allowable credit and tonnage sub-limits which are prescribed to You.

You must carefully read the CBH Grain commodity swaption information memorandum and Swaption General Terms before submitting a Swaption Application to CBH Grain. The Swaption General Terms form part of the Swaption Contract in relation to the Swaption.

Please note: The capitalised terms used in this Swaption Application have the meaning given in the Swaption General Terms unless otherwise defined in this Swaption Application.

5.1 WHOLESALE CLIENT AND OTHER MATTERS

You represent and warrant to CBH Grain that:

- (a) in entering into the Swaption Contract You have relied on Your own skill and judgment and have taken, or have appropriately considered taking, independent advice on the Swaption Contract;
- (b) You have not relied in any way on the skill or judgment of CBH Grain or any of CBH Grain's staff or representatives as advice or a recommendation or guarantee of result in respect of the Swaption Contract;
- (c) You have not relied in any way on any representation made by CBH Grain that has not been expressly stated in these Swaption General Terms;
- (d) You fully understand and accept the pricing risks involved in the Swaption Contract (and any Reference Swap determined upon exercise of the Swaption);
- (e) anything You have stated in a Swaption Application is true and correct;
- (f) You are entering into and exercising the Swaption Contract for the sole purpose of hedging Your actual or reasonably expected physical position;
- (g) You are 'wholesale client' under the Corporations Act;
- (h) You fully understand the legal and financial implications of being a wholesale client under the Corporations Act; and
- (i) You acknowledge and accept that the protection provisions of the Corporations Act which apply to retail clients will not apply to You in connection with the Swaption Contract.

You acknowledge that CBH Grain, in entering into the Swaption Contract, is relying on the accuracy of the warranties given by You in this clause 5.1. If any warranty is not correct at the time it is made or when it is deemed to be repeated, by reference to the facts and circumstances then subsisting, CBH Grain may not be able to provide some part or all of the services to You under the Swaption Contract, or equivalent services, and may otherwise suffer loss or damage.

5.2 ACCURACY OF THE INFORMATION IN THIS SWAPTION APPLICATION

You:

- (a) agree to indemnify CBH Grain and each of its Related Bodies Corporate and each of their directors, employees and officers against any claim, action, damage, loss, liability, cost or charge they may suffer, incur or be liable for as a result of any incorrect or misleading or deceptive information disclosed in or in connection with this Swaption Application unless caused by CBH Grain or its Related Bodies Corporate's gross negligence, wilful misconduct or fraud; and
- (b) authorise CBH Grain and each of its directors, employees, officers, agents and contractors to complete or amend this Swaption Application where necessary to correct any errors provided that CBH Grain must promptly notify You if it takes any action under this clause 5.2(b).

5.3 AUTHORITY TO SIGN

Each person signing this Swaption Application on behalf of You declares, represents and warrants to CBH Grain that they have been duly authorised by You to sign this Swaption Application on behalf of You and to bind You.

5.4 AUTHORITY TO ACCESS INFORMATION

You irrevocably and unconditionally authorises Co-operative Bulk Handling Limited (**CBH**) to inform and provide CBH Grain with (i) Your historical production and delivery information for the current year and the previous ten years; and (ii) information relating to Your creditworthiness, credit standing and credit and payment history, for the purposes of ascertaining Your risk and credit profile and acknowledges that without this information, CBH Grain may not be able to consider or approve this Swaption Application.

5.5 PERSONAL INFORMATION

Information about You and/or Your signatories is collected for the purposes of entry by You into a Swaption, as well as providing grain storage, handling, transport, marketing and accumulations services to You as a grower. The information may be provided to CBH Grain's Related Bodies Corporate (including CBH). Your contact details

may also be used by any member of the CBH Group to communicate issues that could be of interest to You as a shareholder in CBH.

In entering into a Swaption, You consent to the use and transmission of the information.
